Discussion of the Corrective Action Plan (CAP)

Item: Update on the CAP (Dr. Gail M. Fowler)

Conclusion: The CAP is a fluid document and will change as we move throughout the year. The updates will include what rigor looks like, as well as the areas affected. The STAR Based Program, STEM and STEAM have been added to the connections rotation so that all of the children will have access to explore higher thinking skills and problem solving. The deans have done a good job in setting up the instructional calendars for higher learning instructional strategies.

The Academic Deans will be working to obtain Mathematics Endorsements to work with the teachers on numeracy. Ms. Edwards will obtain evidence of our efforts to submit showing that we are doing what we submitted in the CAP. Ms. Sarah Miller, Media Clerk, is passing out books so that every child will have a book they can take home.

One of the teacher leaders will need to be replaced in the middle grades. Teachers will learn how to teach on a higher level in the classroom and began issuing AR testing to go along with the books read. Students will begin checking out books in the Media Center and teachers will schedule time in the AR Lab; the paper to support this effort has been distributed.

The afterschool program will begin on September 19th and thus far, there are 225 students enrolled. Those who have not enrolled, however are required to due to academics, will be contacted by the registrar, Ms. April Dean.

Children and staff will be allowed to dress as their favorite book characters on October 31, 2022.

Action Items:

Ms. Edwards will provide resources for instructional rigor.

Dr. Fowler will speak with Ms. Binns and the Academic Deans around getting a handle on what is happening with behavior, issues with teachers and progression data.

Ms. Riley will work with the Academic Deans in creating a climate survey for bi-weekly distribution. The data will be shared with the team for action wherever needed.

Comments

Item: It was suggested that the board members come to the school and read to the children once or twice a semester.

Conclusion: Mr. Rogers will bring it up at the next board meeting.
